ORDER

The matter of speedy disposal of applications seeking allotment of land in various Industrial Parks of the Corporation was under active consideration of the Corporation for quite some time past. Upon careful consideration of the existing land allotment procedure, the Corporation has decided to adopt the **Standard Operating Procedure (SOP)** for single pending case, following Notification No. I/223218-ICE-14011(99)/22/2020-IPI SECTION dated 28th September, 2022 of the Department of Industry, Commerce & Enterprises, Government of West Bengal.

The Standard Operating Procedure (SOP) for Online Land Allotment for single pending case in WBIIDC will be as follows:-

- The Detailed Project Report completed in all respect will be evaluated and approved within 02 (two) weeks of its submission.
- 2. The Board Agenda notes along with 15 days' meeting notice will be circulated to the Board Members within 7 (seven) days from the date of approval of DPR.
- 3. In compliance of the Gazette Notification No. I/223218-ICE-14011(99)/22/2020-IPI SECTION dated 28th September, 2022, the land allotment proposals for single pending case along with evaluated DPR will be placed before the Board of WBIIDC within next 07 (seven) days from the date of approval of DPR.
- **4.** In order to expedite the land allotment, all such proposals be placed before the Board of the Corporation, if required, through video conferencing.
- 5. Minutes of the Board Meeting shall be prepared and placed before the Chairman, WBIIDC for his approval and signature within 3 (three) days from the date of Board Meeting.
- **6.** Signed minutes of the Board Meeting along with Cabinet Memo. will be sent to the Industry, Commerce & Enterprises dept. for placing it before the Cabinet within **03 (three) days** from signing of the minutes.

Timeline mentioned in Gazette Notification No. I/223218-ICE-14011(99)/22/2020-IPI SECTION dated 28th September, 2022 shall be followed for subsequent actions after obtaining the signed minutes from the Chairman, WBIIDC.

The above SOP has the sanction of the Board of this Corporation vide Misc. Table Agenda Item No.1 of the 149^{th} Board Meeting and will be operative with immediate effect.
