The Superintending Engineer, WBIIDC invites tender on **item rate basis** from bonafide experienced and resourceful agency(s) having requisite documents for participating in the tenders of Govt. Department.

**Providing Pump Operator for operating several pumps including fire pumps for day to day water supply to entrepreneurs along with emergency water supply for firefighting at Bishnupur Industrial Park, Vill & P.O.-Dwarika, District- Bankura, PIN-722122, for the period of October 21 to September 22.**

Tender Documents will be issued to the agencies on fulfillment of respective criterions. Unauthorized rate quoted in whatsoever manner by any participants who has not been permitted for issue or documents will not be considered & will be treated as fake documents. The Rate should be quoted both in figures and words.

The sealed offers must be dropped in specified tender box kept in the office chamber of The Superintending Engineer, WBIIDC

The eligible participants must quote the rate with his knowledge & belief after going through the item/items of the work. The rate(s) must be quoted both figures & words. Intending participants are requested to visit the site before quoting their rates.

Terms & Conditions:

1. The intending bidders will have to quote their rates in the specific schedule of items. Copy of Notice Inviting Tender and Price Schedule to be obtained from departmental website [www.wbiidc.org](http://www.wbiidc.org)
2. The rate must include all taxes of State Government, Union Government (like P.T, I.T & GST) & the cost of carriage & all other incidental charges. Necessary deduction i.e. GST, IT, Cess will be as per relevant Govt. order.
3. The eligible bidders are required to quote their rates both in figures and words for each item of work, as applicable.
4. The authority accepting the bid reserves the right to accept/reject any/all bids without assigning any reason whatsoever. All terms and conditions are as per existing Rules.
5. **Duration/ Time of Completion** is for the period of October' 21 to September' 22.
6. The notice is available at the department Website and all other relevant documents for this office of the the Superintending Engineer, WBIIDC.

7. The Bids will be received in tender box lying at the chamber of the the Superintending Engineer, WBIIDC up to 24.09.2021 along with this notice duly signed and will be opened on the same day at 3.00PM in the presence of attending bidders who may be present at the time of opening and no complaint will be entertained.
8. Man-Power deployed should be paid minimum rates of wages under the Minimum Wages Act, 1948 as applicable for Pump Operator as declared by the Labour Commissioner, Govt. of West Bengal from time to time. They should be paid the benefit as per EPF/EPF Act, ESI Act etc. Agency shall be wholly and exclusively responsible for due performance for the Entire obligation under Contract Labour (Regulation and Abolition) Act, 1970 and Department shall not in any way be responsible for the breach or violation of any of provision under the said Act and Rules thereunder.
9. Minimum Wages for Labour (Semi-skilled) should be calculated in following manners as per order Circular No. 48/Stat/2RW/32/94/LCS/JLC dated 30.06.21 of Labour Commissioner, Statistic Section, Government of West Bengal.

10. Rate Analysis of quoted rate as per given format of clause 9 in this NIT should be submit along with bid papers at time of dropping in Tender Box.
11. The Successful bidder for each work shall have to enter in to an agreement in W.B.I.I.D.C. Form No. 1 by depositing @2% Earnest money on the quoted amount through online/Bank Draft/ Pay order of any Nationalised Bank payable in favour of the West Bengal Industrial Infrastructure Development Corporation failing which the accepted quotation is liable to be treated as cancelled. Security money @ 1% will be deducted from the progressive bills in addition to earnest money to make it a total deposit of 3% (ten percent) of value of work.
12. No conditional bid will be accepted.
13. **The Selected agency has to abide by all Health Protocol and guidelines issued by the Govt. of West Bengal and other Statutory Bodies regarding safety of workers and others in view of COVID-19 context, during execution the work.**
14. The agencies participating in the bid are supposed to visit the site of work for being acquainted with the local condition and difficulties, if any under which the work will have to be carried out. No claim on this ground shall be entertained after acceptance of bid.

Intending participants are requested to follow /maintain all Health protocol and guidelines issued by the Govt. of West Bengal for combating COVID-19 throughout the whole tender process starting from application for tender participation to bid submission.
